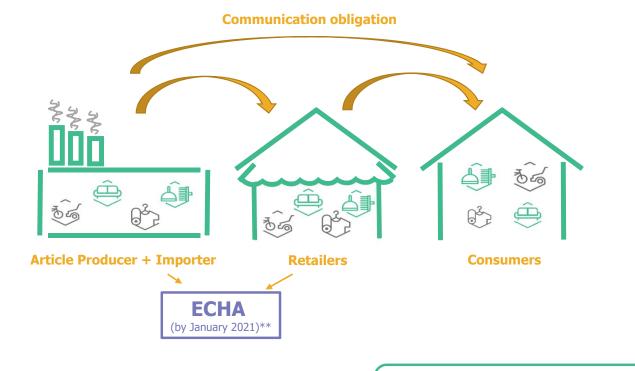

Lack of communication on SVHC in articles

- along the **supply chain**
- between consumers and article suppliers

May cause risks to human health and the environment

- Receive statistics on customer requests.
- Get a reminder for information update every time new substances are identified as SVHC.
- Promote also SVHC free articles via the app.

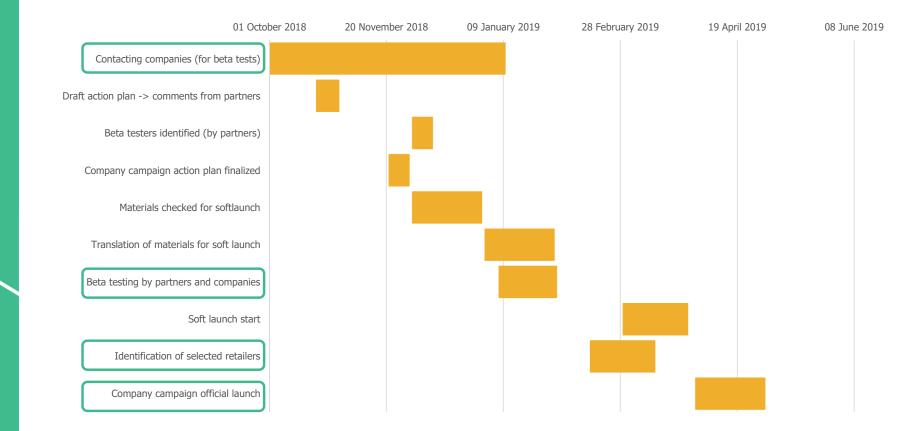

- App testing by selected group of consumers.
- Campaign official launch in spring/early summer 2019

- Customer information
- Training of shop assistants
