## Highlights of the tenth plenary meeting of ECHA Forum

Forum members reviewed the results of the prolongation of the first Forum coordinated enforcement project (registration obligations for phase-in substances; Safety Data Sheets from substance suppliers) and agreed on the subjects of the third enforcement project (verification of the registrations by Only Representatives; cooperation with custom authorities controlling imports of substances; partly also verification of registrations for intermediates). The meeting, held from 3 to 5 October 2011, was followed by the second Stakeholder Workshop. You will find more information here.

# REACH registration: invitation to companies to start for preparing for the 2013 deadline



At the REACH Conference on 23 September, ECHA launched the 'REACH 2013 - Act Now!' campaign to remind the industry to start preparing for the second REACH registration deadline. Companies manufacturing or importing chemicals in quantities at or above 100 tonnes per year are required to register these substances with ECHA by 31 May 2013.



# Report of the Directors' Contact Group (DCG) available

The European Commission has published the Report of the Directors' Contact Group presenting achievements, lessons learnt and recommendations from the Directors' Contact Group between the European Commission, ECHA and Industry Associations on meeting the first REACH registration deadline. ## ECHA publications following first registration deadline

#### Analysis of substances not registered in 2010

ECHA published a list of around 1500 substances not yet registered at the first deadline despite the reported intentions identified according to a survey carried out in April 2010. The Directors' Contact Group (DCG) agreed to conduct an analysis of the reasons, and ECHA published the results on its <u>website</u>.

#### Removal of invalid pre-registrations

ECHA supports the data sharing process between registrants by removing invalid pre-registrations from its database. You can find more information <a href="here">here</a>.

## **ENES: Exchange Network on Exposure Scenarios, set up by ECHA**

ENES is a new network which aims at identifying good industry practices on drafting exposure scenarios and building a dialogue between supply chain actors to improve the protection of human health and the environment. More information can be found in ECHA's News Alert.

## **Draft plan for first substance evaluation submitted to the Member States**

ECHA has submitted the first draft Community rolling action plan (CoRAP) to the Member States which contains 91 substances that are proposed for review by the Member States under the substance evaluation process of the REACH Regulation. These substances will be evaluated during the years 2012, 2013 and 2014. ECHA publishes also a <u>public version</u> of the draft plan including the non-confidential substance names, CAS- and EC-numbers, and the tentative year of evaluation.

# ECHA launches a new procedure for submitting Alternative Chemical Name Requests

A new <u>online form</u> allows manufacturers, importers and downstream users to request the use of alternative chemical names if they believe that the disclosure of a substance name on the label of their mixtures or in the safety data sheets reveals business secrets. This is in accordance with Article 24 of the CLP Regulation.
