ECHA publishes its first five-year strategic plan for public consultation

Citizens and organisations are invited to comment on ECHA's draft Multi-Annual Work Programme 2014-2018, which is structured around the Agency's four long-term strategic goals. The four strategic objectives set out a high level, aspirational approach to achieving a broad and long-term perspective on the safe use of chemicals in Europe.

The draft programme is available in 23 EU languages. ECHA is looking forward to receiving comments by 15 July 2013 and will take them into account when finalising the multi-annual work programme.

REACH (Registration, Evaluation, Authorisation and restrictions of Chemicals)

Second REACH deadline: 2,923 substances registered

By the second REACH deadline of 31 May 2013, 9,084 registration dossiers have been submitted by 3,215 companies to the European Chemicals Agency (ECHA). The final number of successful registrations and substances submitted will be available in early September when all dossiers have been processed.

Remember that your registration will only be considered complete, if the <u>registration fee is paid</u> within the deadline indicated in your invoice. In the framework of REACH 2013 deadline, ECHA also provides a section on "<u>Information for downstream users</u>" on how to find out whether your substances has been registered and what to do next.

Reminder: Next deadline for SiA notification is 19 June

Under certain conditions (see Article 7 REACH), importers and producers of articles have to submit notifications of substances in articles (SiA) to ECHA six months after the inclusion of these substances in the Candidate List. The 54 substances of very high concern (SVHC) that were added to the Candidate List on 19 December 2012 thus have to be notified to ECHA by 19 June 2013.

Autorisation:

New substances in Annex XIV

The <u>list of substances subject to authorisation</u> has been extended by <u>Regulation (EU) 348/2013</u>. The following substances were added: Ammonium dichromate, Potassium chromate, Acids generated from chromium trioxide and their oligomers (Group containing: Chromic acid, Dichromic acid, Oligomers of chromic acid and dichromate acid), Chromium trioxide, Potassium dichromate, Sodium chromate, Sodium dichromate, Trichloroethylene.

Clarification of submission deadline and seminar

The Commission has <u>clarified</u> that if an application for authorisation is submitted before the 'latest application date' (LAD), the applicant can continue to use the substance after the 'sunset date', while waiting for the Commission decision. Accordingly, ECHA adapted its submission windows so that they last until the LAD.


Evaluation:

Germany has notified ECHA of the need to add an additional substance to the Community rolling action plan (CoRAP) 2013-2015 for immediate evaluation. Based on the notification by Germany, ECHA is considering the inclusion of 1,4-benzenediamine, N,N'-mixed phenyl and tolyl derivs (CAS 68953-84-4, EC 273-227-8, known as BENPAT) in the CoRAP. BENPAT is used for the manufacture of rubber products, including tires. More information in ECHA's press release.

Restrictions:

A public consultation is still going on lead and its compounds until 21 September 2013 and Bisphenol A (4,4'isopropylidenediphenol) was added to the <u>register of intentions</u> for restriction proposal.

${\sf CLP}$ (Classification, Labelling and Packaging of substances and mixtures)

CLP: Fourth Adaptation to Technical Progress published

Regulation (EU) No 487/2013 of the Commission of 8 May 2013 amending CLP regulation for the purposes of its adaptation to technical and scientific progress (ATP) has been published in the Official Journal (L 149, 1/6/2013).

The CLP Regulation is based on the Globally Harmonized System (GHS) of Classification and Labelling of Chemicals of the United Nations. The fourth revision of the GHS was adopted in December 2010. It was therefore necessary to align the provisions of the CLP.

The main changes include:

- New hazard categories for gases chemically unstable and non-flammable aerosols and rationalization of hazard statement.
- Labelling for substances or mixtures classified as corrosive to metals but not corrosive to the skin and / or eyes.

A transitional period is foreseen to allow chemical suppliers to adapt themselves to the new rules on classification, labelling and packaging introduced by this regulation, which is applicable for substances from 12/01/2014 and for mixtures from 06/01/2015. However, there are two years' exceptions for chemicals already on the market at the date of application of the regulation, but it is also possible to take into account the changes before these deadlines (see Article 2 of the fourth ATP).

CLP: On-going public consultations

In the framework of CLP, several public consultations have been launched by ECHA concerning harmonised classification and labelling (HCL) and a draft opinion from Committee for Risk Assessment (RAC). The public consultations are the following:

- Public consultation on RAC's draft opinion on the toxicity to reproduction of gallium arsenide: The comments received during the public consultation will be regularly published on the ECHA website during the 21-day consultation period which ends on 19 June 2013.
- HCL public consultations on lenacil and boric acid, open for 45 days until 28 June 2013
- HCL public consultations on tributyltin compounds and PHMB, open for 45 days until 22 July 2013
